**PsyCheck Train the Trainer Workshop – 10 & 11 February 2009:** The PsyCheck Screening Tool is a mental health screening instrument designed for use by clinicians who are not mental health specialists. It is designed to detect potential mental health problems that may be missed if not specifically investigated by the clinician or raised by the client. Turning Point will be providing eight 2-day train the trainer courses. The two-day courses will provide participants with an orientation to the PsyCheck resources. These courses are aimed at senior alcohol and drug, mental health and dual diagnosis clinicians and trainers.
