## Call for abstracts

NADA invites abstract submissions for oral papers, workshops, panel presentations and poster presentations for the NADA Conference 2018: Exploring therapeutic interventions.

This is an opportunity for you to showcase your innovative practice and research addressing the diverse and complex needs of people accessing AOD services. Interactive sessions are encouraged to maximise opportunities for conference participants to exchange practice and experience.

# Submission guidelines

## How to submit your abstract

Email your submission to [conference@nada.org.au](mailto:conference@nada.org.au) by **Wednesday 28 February 2018 at 5pm EST**.

## Abstract format and guidelines

- Abstracts body text should be a maximum of 200 words, using Arial, 11 point font size, and justified.
- Abstracts must show the title of the paper, paper type, a/v requirements, name of the presenter/s, contact details, and their affiliations.
- Abstracts should clearly demonstrate positive outcomes (for people, organisations, workforce), or lessons learnt from outcomes that weren't successful.
- Abstracts showcasing research should clearly demonstrate how it can be applied to practice.
- A brief biography (100 words) for each presenter must also be submitted with the abstract.

**Presentation type:** oral, poster, workshop

**Audio visual requirements:** video presentations, etc

## Submission options

**Paper presentations** provide authors the opportunity to present original work related to conference topics. Oral paper presentations will have 30-minute time slots and be clustered by theme into sessions.

**Workshops** provide authors the opportunity to present their work in highly interactive manner and maximises audience participation. Workshops will have 30–40 minute time slots, with at least 25% of the total allotted time devoted to questions and answers, or to group interaction.

**Lightning round presentations** provide authors the opportunity to share their work in brief oral presentations. Each presentation is limited to 10 minutes, followed by a five-minute question-and-answer period.

**Panel presentations** provide authors the option to organize a panel comprising three related presentations. Panel presentation sessions will be 60 minutes long, with 40 minutes for the presentation and 20 minutes for discussion.

**Poster sessions** provides an interactive forum for authors to discuss their work. All individual submissions will be considered for poster presentation if not accepted for their original submission type.

## Abstract submission process

Abstracts will be reviewed by the Conference Organising Committee based on relevance to themes, innovation and originality, practical application, and clear articulation of outcomes.

Applications will be notified of their success in March 2018. Guidelines for the preparation of oral and poster presentations will be provided upon acceptance.

The selection committee reserves the right to propose alternative presentation formats as the scope of the final programs requires.
